Benefits for Individuals

- Receive a Pennsylvania state income tax credit of up to 90% of their contribution.
- Receive a 10% federal itemized charitable deduction.
- Directly support the education organizations of their choice.
- Provide educational opportunities for deserving students.

The EITC program allows you to donate a lot for a small cost. The following chart illustrates the the tax benefits.

	Contribution	PA State Credit	Federal Deduction	Out of Pocket Cost
EITC Gift	\$10,000	(\$9,000)	\$250	(\$750)
Typical Gift	\$10,000	\$0	\$2,500	(\$7,500)



Commonly Asked Questions

How do I enroll? Donors join a special purpose entity (SPE) by signing a joinder agreement, which grants access to tax credits and allows them to designate a Pennsylvania approved educational organization. Once enrolled, donors send their contribution to Friends of Education who ensures the donation reaches the organization of their choice.

How does redirecting my taxes benefit children in Pennsylvania? By directing tax dollars to educational organizations dedicated to educational equity, donors play a vital role in expanding access to quality education for children in Pennsylvania, equipping them with the tools and opportunities they need for a brighter future.

How does this work if I file jointly with my spouse? Only one eligible spouse should enroll; the tax credit applies to joint Pennsylvania tax liability, even if the other spouse is the primary earner.

Next Steps

- 1 Speak with your tax advisor to determine whether you are eligible to participate.
- 2 Request a joinder agreement to specify your two-year commitment by emailing info@pataxcredits.org.
- 3 Make your first contribution as outlined in the joinder agreement.
- 4 Attach the Form K-1 (received in February) to your PA state tax return.

Eligibility Requirements

- ✓ Donors must have Pennsylvania-sourced income, meaning they must be employed by, a shareholder of, or a partner in or member of (i.e., own an interest in an LLC) a business that pays taxes in Pennsylvania.
- ✓ Donors must be current on all state and federal tax obligations.
- ✓ Donors must be prepared to make a two-year commitment of \$5,000 or more per year.
