

Where We Work

Our work is in the Wissahickon watershed consisting of 64 square miles of land that drains into the Wissahickon Creek with our focus on the Montgomery County, PA portion of the watershed. It is our responsibility as a land conservation organization to recognize the history of the land we steward and to acknowledge that it is the traditional and ancestral territory of the Lenni Lenape people.

About Wissahickon Trails

We believe that people benefit when nature thrives. In 1957, nine community members turned their concerns about flooding in the Wissahickon Valley into a trusted, local nonprofit. Since then, Wissahickon Trails has preserved 1300 acres of open space on 12 preserves with 24 miles of hiking trails. In addition, we monitor water quality in the Wissahickon Creek and provide education opportunities for schools and the public.

PUBLIC PROGRAMS

(Levels starting at \$3,000)

More than 3,000 community members participate in Wissahickon Trails public programs each year. Sponsoring these programs will have your company name in front of our full audience throughout the year.

Connected Wissahickon Hike Series

This popular guided hike series runs year-round and highlights a range of preserves and trail connections throughout the Wissahickon Valley. Offerings include everything from monthly Power Hikes to leisurely 2-mile walks, appealing to participants of varying interests and fitness levels while reinforcing your company's support for healthy, active lifestyles.



Serve the Preserve

Offered monthly from March through October, Serve the Preserve engages community members in hands-on stewardship activities that support habitat restoration and trail maintenance. These volunteer events help ensure long-term environmental health while maintaining safe and accessible outdoor spaces for the public. All skill levels are welcome, with training and tools provided, making participation inclusive and impactful.

EVENT SPONSORSHIP

(Levels Ranging from \$600-\$25,000)



Maple Sugaring Festival - February or March

Over 300 attendees, mostly families and scout troops, learn about the maple sugar process and its connection to the land and native peoples.



Wissahickon Creek Clean Up - last Saturday in April

Over 400 volunteers span out across the watershed to clean the Wissahickon Creek and its tributaries. Event sponsors receive priority in selecting a cleanup site for their employees to participate.



Tex Mex 5k Race for Open Space - Wednesday in June

Wissahickon Trails has been the main beneficiary for over 25 years. Hosted by Tex Mex Connection restaurant, this popular 5k is a tradition that attracts 1500 runners, 120 volunteers, and the North Wales community.



Craft Beer by the Creek- Fall

This family (and dog) friendly event features live music, local craft beer/cider and food trucks at the Four Mills Barn, Wissahickon Trails' headquarters.



Green Ribbon Gala - Fall

Our largest fundraising event of the year celebrating the Wissahickon Trails' community with 200-250 attendees.

EMPLOYEE ENGAGEMENT

(Levels Ranging from \$600-\$25,000)

Boost employee engagement by hosting a day outside with Wissahickon Trails. These flexible, hands-on projects support land stewardship and community science while being tailored to your team's size, interests, and schedule. Land Stewardship Days

Employees roll up their sleeves to help restore habitats at one of our 12 preserves.

- Trail maintenance including building or repair of boardwalks and bridges
- Planting and maintenance of new trees and shrubs
- Invasive plant removal

Community Science

Teams contribute to real-world environmental research.

- Pollinator projects such as Caterpillars Count and Milkweed Monitoring
- Mini Bio-Blitz using iNaturalist app to collect data on flora & fauna

Nature & Environmental Learning

Guided experiences that inspire connection with nature.

- Staff-led nature walks
- Virtual or on-site Lunch & Learn program with topics such as native gardens, birds, and pollinators



MISSION INVESTMENT

(Cost Varies By Project)

Multi-Year Projects

With 1,300 acres, 12 preserves, and 24 miles of trails to protect and maintain, conservation projects are always ready and available for funding and volunteers. Larger conservation projects will align with our preserve management plans and trail accessibility work.



Community Science Programs

Data collected through programs such as monarch tagging, nest box monitoring, bird banding, and creek watch is used to evaluate and determine preserve management plans. Select program data is also shared with programs that track populations and behavior of wildlife nationwide.



Educational Improvement Tax Credit Program (EITC)

We partner with local school districts to provide both classroom and field-based environmental education to over 2,000 students and teachers. EITC is a state program that supports these programs by providing tax credits to businesses that make financial contributions to approved Education Improvement Organizations, such as Wissahickon Trails.


